Part I. General Expectations

5. Reg. 71710, December 2, 2002):

All New Manchester Elementary School staff members are highly qualified.

- 8. The New Manchester Elementary School shall provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below:
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - · the state and local academic assessments including alternate assessments,
 - the requirements of Title I Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Parent-Teacher Conferences to explain test results, School Open House, informal parental contacts, individual parental mailings, and County/School Report Cards will be used to inform parents regarding content standards, achievement assessments, and student led conferences to view and discuss individual student data binders, and Edline.

9. The New Manchester Elementary School shall provide materials and training to help parents work with their children in the areas of improving student achievement, (including literacy training and using technology) child development, child rearing and additional topics parents may request.

The Title coordinator will work with the principal and Title I teacher in helping parents improve student's academic achievement via training. Parents will be involved in previewing and selecting resource books, videos, brochures which other parents might find useful.

10. The New Manchester Elementary School shall, with the assistance of its parents, educate its teachers, pupil services personnel, principal and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Our staff conducts staff development training for relationships with parents throughout the school year. Our LSIC holds meetings throughout the year in order to bridge the relationship between teachers and parents. Our NMES Faculty has two representatives on the PTA executive committee. Teachers also attend workshops and training sessions to enhance their skills to assist parents and students.

11. The New Manchester Elementary School shall, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

Booklets will be given to parents for use with their pre-K child in introducing skills needed in reading for kindergarten. Training will be given to Pre-K parents on how to provide instruction in phonemic awareness activities and language skills through every day play, communication, and daily life experiences.

The New Manchester Elementary School shall take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

All school notices will be translated and sent home with LEP students.
